Objective: The seminar will focus on the **EU regulatory framework** supporting the reduction of energy poverty, in particular the use of renewable energies by vulnerable groups. It will review current EU strategies and plans, discuss current regulatory framework in the project partners regions and provide insights for the revision of EU directives.

Context: The Covid pandemic has highlighted the deep inequalities in society and across the regions of Europe. Energy poverty is recognised as a widespread problem, with serious consequences for health and well-being. Besides housing energy efficiency issues, the production of renewable energy by vulnerable groups remains a major challenge. In support to the EU green deal, the Commission has released the Renovation Wave strategy including measures to address Energy Poverty. This strategy will lead to the revision of EU directives such as the renewable energy and energy efficiency directives.
